3. DEPARTMENT REMAINS CONCERNED ABOUT ARMS TRAFFICKING TO THE BELLIGERENTS IN RWANDA. WE BELIEVE THAT AUTHORITIES -- WITH EITHER THE ACTIVE OR TACIT SUPPORT OF SENIOR OFFICIALS -- CONTINUE TO PERMIT ARMS AND MATERIEL TO REACH THE RPF AND THE RWANDAN MILITARY.

EMBASSY KINSHASA HAS MADE DEMARCHES TO THE GOZ, ALTHOUGH NOT DIRECTLY TO MOBUTU (SINCE HE RESIDES MORE OR LESS PERMANENTLY IN

GBADOLITE).
