1. WE APPRECIATE THE AID/STATE'S EFFORT IN LOCATING  
ADDITIONAL TALENT TO JOIN WITH OUR ADMINISTRATION OF  
JUSTICE TEAM IN ADDRESSING HOW BEST TO HELP RWANDA  
QUICKLY SET UP A JUDICIAL SYSTEM THAT CAN MOVE FORWARD ON  
THE DISPOSITION OF PRISONERS NOW OVERCROWDING RWANDA'S  
JAILS. THE PROPOSED TIMING OF PROSPER'S TRIP, HOWEVER,  
DOES NOT AUGUR WELL FOR WELL FOR THE ACHIEVEMENT OF HIS  
TASK:

-- THE COUNTRY IS GOING INTO DEEP MOURNING FOR A WEEK BEGINNING APRIL 7; GOVERNMENT OFFICES WILL FOCUS ON LITTLE ELSE THAN THE CEREMONIES BURYING THE DEAD AND MEMORIALIZING GENOCIDE FROM APRIL 7-14.

-- OUR ADMINISTRATION OF JUSTICE TEAM IS SCOPING OUT MANY OF THE ADMINISTRATIVE CONSTRAINTS TO THE DELIVERY OF JUSTICE IN RWANDA. MR. PROSPER CAN GET MORE QUICKLY TO THE NUB OF THE PROBLEM HE IS ADDRESSING IF HE BUILDS ON THEIR WORK, READY IN DRAFT IN ANOTHER WEEK.

-- WE MUST BRIEF RWANDAN AUTHORITIES ON PROSPER'S INTENDED TRAVEL AND WITH THEIR HELP MESH HIS EFFORTS WITH WORK ALREADY UNDERWAY, FOCUSING THIS EFFORT ON CRITICAL NEEDS OF THE JUDICIAL PROCESS IN RWANDA. THIS CANNOT BE DONE BEFORE PROSPER'S INTENDED DEPARTURE FROM CALIFORNIA ON APRIL 4.

2. I, THEREFORE, REQUEST THAT MR. PROSPER PUSH BACK HIS DEPARTURE FROM THE UNITED STATES FOR ONE WEEK FROM THE PROPOSED APRIL 7 TIMEFRAME. COUNTRY CLEARANCE IS GRANTED ON THAT BASIS.
