I. GEN SITUATION: CALM.

II. FACTIONAL ACTIVITIES.

A. POLITICAL. SRSG HELD A MEETING ON 061100 JAN 94 WITH THE AMBASSADORS OF SEVERAL COUNTRIES LED BY THE PAPAL NUNCIO, DEAN OF THE DIPLOMATIC CORPS. VIEWS WERE EXCHANGED ON THE POLITICAL SITUATION AFTER THE UNSUCCESSFUL SWEARING-IN CEREMONY FOR THE BBTG ON 05 JAN 94. A NEW SWEARING-IN CEREMONY HAS BEEN ANNOUNCED FOR TOMORROW 080930 JAN 94.

B. MILITARY:

(1) RGF: TROOPS OF PRESIDENT GUARD REGIMENT CARRIED OUT FIRING PRACTICE IN THEIR CAMP KIMIHURURA IN KIGALI CITY.

A. HQS. FC WENT TO MULINDI TO MEET RPF CHAIRMAN.

B. SECTORS:

(1) KIGALI. PROVIDED ARMED ESCORT FOR RPF CHAIRMAN FROM MULINDI TO KIGALI. CARRIED OUT MOBILE AND FOOT PTL WITHIN OAR IN ORDER TO ENSURE KIGALI WEAPON SECURE AREA. ONE WEAPON WAS CONFISCATED. SECURED: (A) THE LOCATION OF THE RPF BATTALION IN KIGALI CITY; (B) PREMATURE; (C) FORCE HQ AND (D) SEC HQ. DURING THE NIGHT ASSURED PROTECTION FOR SRSG, FORCE COMD, PRIME MINISTER, PRIME MINISTER DESIGNATE, PRESIDENT OF THE CONSTITUTIONAL COURT AND 6 MINISTER RESIDENCES.

(2) DMZ: CONDUCTED ROUTINE PTL WITHIN OAR. IT WAS OBSERVED THAT THE RGF CHECK POINTS AT KALINGORERA (7525) HAVE BEEN REMOVED. SCHOOLS AND MARKETS HAVE ALSO BEEN OPENED IN THIS AREA. PROVIDED SECURITY FOR ICRC FOOD DISTRIBUTION POINT AT KIRAMBO (8335).

C. MILOB. CARRIED OUT AN AERIAL RECCE PATROL OF THE REFUGEE SITES NORTH-EAST OF KIGALI. CONDUCTED ESCORT FOR RPF.

D. UNOMUR. CONDUCTED ROUTINE PTL WITHIN OAR.
