(REF) TO AMBASSADOR SHANI LWENO, DIRECTOR OF THE MFA'S AFRICAN/MIDDLE EASTERN AFFAIRS DIVISION, POLOFF STRESSED OUR HOPE THAT THE GOT COULD TAKE ADVANTAGE OF ITS GOOD RELATIONS WITH CHINA TO WEIGH IN WITH THE PRC ON THE TRIBUNAL ISSUE. LWENO CONFIRMED GOT SUPPORT FOR THE ESTABLISHMENT OF A UN WAR CRIMES TRIBUNAL FOR RWANDA AND ASSURED HE WOULD RELAY USG REQUEST TO HIS PRINCIPAL SECRETARY. LWENO ALSO NOTED THAT AN APPROACH TO THE CHINESE WOULD HAVE TO BE APPROVED BY FONMIN RWEGASIRA WHO HAS BEEN OUT OF TOWN ATTENDING A SADC SUMMIT IN BOTSWANA. RWEGASIRA IS EXPECTED BACK LATER TODAY OR TOMORROW.
