1. TODAY PC MAS REQUESTED TO ATTEND UNSCHEDULED MEETING WITH PRESIDENT. ALSO IN ATTENDANCE WERE HR URASA AND HR MCLADGHLIN OF UNICE, AND GOVT STAFFERS. TOPIC OF THE MEETING WAS UNICE, SPONSORED "REPORT" BY HR GERSONY, BRIEVED TO HR AMMAN ON 20 SEP, AND ITS SERIOUSLY DAMAGING MYNCT ON HIS GOVT. PARS MANYED AND ITS SERIOUSLY DAMAGING MYNCT ON HIS GOVT. PARS MANYED TO SEC GEN, WHICH HE INTENDED TO STRONG MESSAGE TO BE CONVEYED TO SEC GEM, MEICH HE INTE
