- 2. SUMMARY: WEEKEND MANEUVERING SAW NO PROGRESS ON THE IMPASSE OVER INSTALLATION OF TRANSITION INSTITUTIONS. POSTURING BY ALL POLITICAL ACTORS, INCLUDING PRESS RELEASES, PRESS CONFERENCES, STATEMENTS AND EVEN DEMONSTRATIONS, WERE UNHELPFUL IN POINTING THE WAY TO COMMON GROUND FOR COMPROMISE.

WESTERN DIPLOMATS TOOK THE OFFENSIVE, MEETING WITH PRESIDENT HABYARIMANA, THE PRIME MINISTER-DESIGNATE, AND THE RPF PRESIDENT TO IMPRESS UPON THEM THE URGENCY OF RESOLVING THE IMPASSE.

FOLLOWING MEETING WITH DIPLOMATS, PRESIDENT SIGNALED UNAMIR POSSIBLE WILLINGNESS TO ACCEPT MINISTERS OF PRIME MINISTER-DESIGNATE. THE PRICE IS NOT YET CLEAR. THE LONGER THE STALEMATE PERSISTS, THE GREATER THE RISK OF A RETURN TO VIOLENCE BY ONE SIDE OR THE OTHER. WESTERN DIPLOMATS WILL MEET AGAIN TODAY WITH UNAMIR TO REVIEW THE STATE OF PLAY IN ADVANCE OF THE SECURITY COUNCIL MEETING JANUARY 5.

THE MORNING NEWS ON NEW YEAR'S DAY CARRIED A PRESS RELEASE FROM THE PRIME MINISTER'S OFFICE ANNOUNCING THAT THE CEREMONY HAD BEEN CANCELED BECAUSE THE PRESIDENT REFUSED TO TAKE THE OATH OF OFFICE ON THAT DAY.

DEMONSTRATION ATTRACTED BETWEEN THREE AND FIVE HUNDRED PEOPLE AND WAS AT TIMES VIOLENT WITH DEMONSTRATORS THROWING ROCKS AT PASSING CARS.

- IN AN INTERVIEW WITH RADIO FRANCE INTERNATIONAL (RFI), PRIME MINISTER-DESIGNATE TWAGIRAMUNGU BLAMED THE PRESIDENT FOR BLOCKING INSTALLATION OF THE TRAMSITION INSTITUTIONS. HE THREATENED TO PROCEED WITH FORMING THE GOVERNMENT WITHOUT THE PRESIDENT'S BLESSING IF HE CONTINUED TO OBSTRUCT. IN A STATEMENT READ BY TWAGIRAMUNGU ON RADIO RWANDA EVENING OF 1/2, HE ANNOUNCED THAT HIS NEGOTIATIONS WERE AT AN END AND COULD ONLY BEGIN AGAIN IF THE PRESIDENT INSISTED. HE SAID INTERMINABLE NEGOTIATIONS BECAUSE ONE SIDE OR THE OTHER DIDN'T LIKE FACTION X OR Y WOULD LEAD NOWHERE.
- THE MRND HELD A PRESS CONFERENCE EVENING OF 1/2 IN WHICH IT BLAMED PRIME MINISTER-DESIGNATE FOR BLOCKING THE FORMATION OF THE TRANSITION INSTITUTIONS

AND FOR INTERFERING IN THE AFFAIRS OF POLITICAL PARTIES FOR PARTISAN REASONS. THEY ALSO ACCUSED HIM OF CONNIVANCE WITH THE RPF AND SUGGESTED THAT IF HE WAS INCAPABLE OF FORMING A GOVERNMENT, THEN ANOTHER PRIME MINISTER SHOULD BE FOUND.

10. NOT TO BE OUTDONE, THE HARDLINE CDR PARTY, WHICH HAS BEEN VIRTUALLY SILENT UP TO NOW, ANNOUNCED THAT IT WOULD SIGN THE CODE OF ETHICS REQUIRED OF POLITICAL PARTIES PARTICIPATING IN THE TRANSITION CONFIDENTIAL

THE NONCE APOSTOLIQUE SUMMONED THE HEADS OF EMBASSIES OF FRANCE, BELGIUM, GERMANY AND THE U.S. TO A MEETING WITH THE SPECIAL REPRESENTATIVE OF THE SECURITY GENERAL (SRSG) BOOH BOOH MORNING OF NEW YEAR'S DAY. BOOH BOOH APPEALED TO THE DIPLOMATS FOR THEIR HELP IN UNBLOCKING THE SITUATION WHICH HE BELIEVED WAS AT AN IMPASSE. BOOH BOOH SAID THE PRESIDENT WAS VERY AGITATED DURING A 12/30 MEETING, CLAIMING THAT HIS ENEMIES WERE DOING EVERYTHING POSSIBLE TO CHASE HIM FROM POWER AND SAYING THAT HE WOULD REFUSE TO GIVE ARMS TO HIS ENEMIES SO THAT THEY COULD ASSASSINATE HIM. - 13. THE DIPLOMATS DECIDED TO MAKE A JOINT DEMARCHE ON THE PRIME MINISTER, THE PRESIDENT AND RPF PRESIDENT KANYARENGWE TO IMPRESS UPON THEM THE URGENCY OF THE SITUATION. THE DEMARCHE, HIGHLIGHTING THE APPROACHING DEADLINES 1/5 IN THE SECURITY COUNCIL, 1/15 FOR THE INTERNATIONAL FINANCIAL INSTITUTIONS, URGED THAT POLITICAL ACTORS ENGAGE IN CONFIDENCE BUILDING RATHER THAN MUD SLINGING AND THAT THE INSTITUTIONS TRULY BROAD-BASED TO FOSTER NATIONAL RECONCILIATION.
- 14. PRIME MINISTER-DESIGNATE TWAGIRAMUNGU MET WITH THE DIPLOMATS AFTERNOON OF 1/1. HIS RESPONSE TO THE DEMARCHE BLAMED THE ENTIRE PROBLEM ON THE PRESIDENT. HE SAID THE PRESIDENT WANTS GUARANTEES IN THE GOVERNMENT AND IN THE ASSEMBLY SO THAT HE CAN CONTINUE TO EXERCISE POWER AS HE HAD DONE DURING THE SINGLE PARTY ERA. HE ACCUSED THE PRESIDENT OF MANIPULATING THE INTERNAL AFFAIRS OF HIS PARTY, THE MDR, AND ALSO THE PL IN ORDER TO ASSURE HIMSELF OF SUPPORT FROM CERTAIN OF THEIR MEMBERS. THE DIPLOMATS REFRAINED FROM OFFERING CONCRETE SUGGESTIONS. CHARGE SUGGESTED THAT THE INTERNATIONAL COMMUNITY WOULD CONCLUDE THAT RWANDAMS LACKED THE WILL TO IMPLEMENT THE PEACE ACCORD IF THE DEADLOCK WERE NOT BROKEN SOON. 19. AT THE MEETING WITH DIPLOMATS EVENING OF 1/3, UNAMIR OFFICIALS EXPRESSED CONCERN THAT THE SITUATION COULD EASILY DETERIORATE INTO RENEWED VIOLENCE. GENERAL DALLAIRE PUT FORWARD A POSSIBLE SCENARIO WHEREBY THE RPF WOULD RETURN TO MULINDI. HE SAID TAKING BACK WOULD BE MUCH HARDER THAN BRINGING TO KIGALI AND PREPARE TO RENEW HOSTILITIES. HE SPECULATED THAT IF THIS SHOULD HAPPEN, THE RPF WOULD WIN THE NEXT ENCOUNTER.

20. ALTHOUGH THERE IS PLENTY OF BLAME TO GO AROUND, IT DOES SEEM THAT ONE OF THE KEY PROBLEMS IS THE PRESIDENT'S UNWILLINGNESS TO ACCEPT THE OUTCOME OF THE PEACE ACCORD WHEREBY HE CAN NO LONGER BE ASSURED OF CONTROLLING THE GOVERNMENT AND THE NATIONAL ASSEMBLY. LEADER
