Major Pa Kagame, now commander of Rwanda Patriotic Pront (RPF), was at that time in charge of torturing and killing people at Basilma House together with Major Kashaija. Later, Kagame was awarded a scholarship by the United States government for further military training in Kansas. Upon Kagame's return to Uganda, Museveni assigned him to lead the RPF, a half force within the NRA fighting to overshrow the government of rewanda. All the above mentioned Tutsi officers plus many others have undergone advanced military instructions in Cuba and Libya prior to U.S. training. The Libyan training included a required course called "Elimination of Opponents". (Currently there are over 20 military trainees in USA from Uganda).

The above sequential narration of what took place at Basiuma house implicates the government in Kayiira's death. It is nevertheless no substitute to the much awaited report of the famous Scotland Yard. If Scotland Yard was able to investigate and produce a report on the Ouko murder within 110 days, certainly, six years is more than enough time to produce a report on Dr. Kayiira case. It is now up to the British Government to compel Scotland Yard to make public its report on the Kayiira murder. It is unfair to talk about justice and at the same time practice cover-ups or benign negligence of blatant violations of human rights and cold-blooded murderers.

Liquid and fixed assets of Uganda Co-op, Transport Corp. were plundered by tribal appointees. Uganda Commercial Bank is bankrupt due to a huge portfolio of unpayable soft loans which were granted to Tutsis and their surrogates in order to buy an economic basc.

Salim Salch is also in charge of feeding the RPF soldiers. The corn flour factory located at Luzira, which was given to him by Museveni, feeds RPF at the expense of NRA. The entire production is purchased by the Defence Ministry to feed Ugandan soldiers but NRA trucks regularly transport the flour to RPF camps located in Rwanda and Uganda. The entire factory personnel are Tutsi soldiers disguised in khaki factory clothes. General Salim Saleh travels to RPF camps inside Rwanda twice a week via NRA helicopter to boost the morale of their soldiers. General Salim Saleh was allocated the former Uganda Blankets Co. and Uganda Sacks Suitcase industry. The entitle production supports only RPF needs.

The entire production of Mukisa Biscuit at Kawempe is purchased by the Defence Ministry under the guise of feeding NRA soldiers, but ends up in RPF camps. Bata Shoe Co. was bankrupted when all of its products were taken by RPF, while Ugandan soldiers walk bare-footed.

Recently, RPF supporters held a strategy conference in the main hall at Makerere University. The RPF war with Rwanda would stop if Museveni is removed from power.

#### Dr. Kato Accused Tutsis Of Killing Ugandans:

Ugandan soldiers have confirmed that accusation. From the days of the bush war till now, Museveni ordered his tribesmen to kill non-supporter Ugandans by hitting on the head with a hoe, a style termed "obufuuni". At Nakasero, Basiima, Makindye, Gaba and other detention centers, only Tutsis operate the murder chambers where thousands of Ugandans have met their painful torture and death. Among the most notorious executioners at Nakasero have been David Kasura, Muyimba, Kuviringira with Muhwezi as the boss. A few years ago, Katsigazi and his squad cleaned the prisons by killing all inmates. When his activities became known to the public, he was merely transferred to the NRM Secretariat which is a part of the spying network. At Luzira Prison, Tutsis carry out torturing of innocent Ugandans.

The so-called "prison medical department" employs only Tutsis who administer poisoning of detainees including injecting them with HIV contaminated materials. One former prisoner injected with AIDS is Lt. James Luwalira. The prison medical department is run by the following Tutsis: Byai ugaba, Ms. Mbabazi and Ms. Namakula, Lt. Charles Kweziira, Lt. William Muhamanya, Lt. Charles Kivizera, Lt. Willy Wolere, Lt. Twah Kangave, Sgt. John Galabuzi, Sgt. Joseph Ddungu, Sgt. Alex Bashaija, Sgt. John Mugabo, Gideon Toto, Capt. Samuel Byaruhanga now Deputy Operation Commander in RRF inside Rwanda. Kweziira and Niwamanya are the specialists in injecting HIV contaminations to Museveni's political opponents at Luzira. Many Ugandans have died right after being released from prison where they got injected with either ATDS virus or special slow killing poison which was

Ugandans who are deemed capable of challenging the Tutsi sinister plans are labeled "ekipingamiizi" meaning "one who is against the progress of Museveni and his people" subject to instant elimination. For example, Commander Ahamad Sseguya, Commander Kaggwa and Commander Magara Galiho were killed by: Mucunguzi, Kamwanamwana and Simba. Mucunguzi was later posted as chief security officer at Coffee Marketing Board. Major Proof Magala was poisoned. Commander Mugabi, Commander Rubereza were killed. Major Magala Nkubejja was shotat Makindye. Lt. Busagwa was shot at his home at Bayita. (This is the man who used to transport Museveni in a cance on Lake Victoria during the war.) Major Kawesi and Capt. Yahaya were killed in planned car accidents by Tutsis. Major Matovu, Major Boosa and Lt. Jimmy Kizito were shot by Tutsis, Maj. Kiiza, Lt.Col. Kirama, Maj. Frank Kibuuka, Maj. Orwoli, Capt. Namiti, Capt. Ssewanyana, Capt. Ben Kiwanuka, Lt. Faluku Kikubali, Lt. Gguma, 2 Lt. Ssendijja were killed in prison. Around 260 soldiers (all Baganda) who belonged to the 34th and 39th battalions were all shot in Eastern Uganda. Hundreds of native Ugandan soldiers have defected. Bernard Buzabo was killed in a planned "car accident".

The Shariat newspaper of December 1st and 15th reported that some Ugandan soldiers have been detained for one to two years at Makindye barracks without trial. They are held in underground cells for more than a year, tortured daily, underfed and are in deteriorating health. Among the names Shariat revealed are: Private Samuel Mweru, Lt. Ahmada Kamya, Capt. Mugumya Magulumaali, Major Musana, Capt. Matte, Capt. Serbowa Lt. Isaac Ssebulinie, Capt. Kibuuka, Lt Elly Kigozi, Sgt. Kirumira, Lt. Walusimbi, Major Musana, Sgt. John Wamala, Lt. Grace Magumba, Major Ali Chama, Capt, Okum, Lt. Eddie Kaddu, just to mention a few. Some detainces are not allowed to see their relatives. Torturing Ugandans is conducted by Sgt. Francis Mwongole and Capt. Lwey banda, according to the Shariat The Shariat reveals that 50 more Ugandan NRA soldiers were arrested and taken to Makindye underground cells. But NRA fabricated a story that stated those soldiers were taken to Nabisojjo re-organization camp for politicization program but later escaped. It is believed they were all murdered.

These are some of the CRIMINAL INJUSTICES which Dr. Kato and others are challenging. Supporting a brital and evil system like Museveni's, and conniving with Tutsi invaders are acts of treason.

It is a very unfortunate situation to see Uganda spending \$400,000 on American lobbyists within a short time when there is no medicine in government hospitals. It reveals that some American businessmen have championed in creating and nurturing conditions which enhance reguery and corruption in Third World countries such as Uganda. It is inconceivable that an American President could consummate a commercial deal the way those Americans trailed Museveni in Gulu and Kampala. Behind every African dictator, there are found several Western dissolute businessmen busy conjuring loopholes in an attempt to distort cosmetically the ugly reputation of their despot clients for pecuniary gains. After the O.P.I.C. team visited Uganda last summer during which rime they reportedly signed arious business deals with Museveni, they returned home praising the dictator and calling him "the golden boy of East Africa." Coincidentally, the new U.S. Secretary of Conmerce, Ron Brown, has been a partner in the firm of Patton, Boggs & Blow.

(NB: In 1977/78 GENERAL FOOD INC., the largest buyer of Ugandan coffee, hired a powerful lobby ist for \$250,000 to block the Bill in Congress which called for boycotting trade between Ugand, and the United States, but a determined group of Ugandans led by Mr. Kintu, won the battle. U.S. Congress passed the legislation suspending diplomatic relations and boycotting trade with Amin' murderous regime.) Right is might.
