DAILY SITREP FOR 07 DEC 94

1. GEN SITUATION. THE MILITARY SITUATION IN RWANDA CONTINUES TO BE GENERALLY STABLE.

A. ETHIOBATT REPORTED THAT A MAN WAS KILLED AND A CHILD WOUNDED IN BUSHEKERI (GR 9932) DURING THE NIGHT 6-7 DEC 94. MONEY AND PERSONAL POSSESSIONS WERE ALSO TAKEN. LOCALS ALLEGE THAT THE RPA WERE RESPONSIBLE.

B. ZAMBATT HAVE REPORTED THAT AN RPA POLITICAL OFFICER ADDRESSED THE POPULATION OF KADUHA CAMP (GR 4643) ON 06 DEC 94. THE POPULATION BEGAN TO COLLECT THEIR BELONGINGS AND LEAVE THE CAMP SHORTLY AFTER THIS ADDRESS. ONLY ABOUT 300 SICK PEOPLE REMAINED BY 07 DEC 94. THE CAMP HAD A POPULATION OF ABOUT 20,000 ON 06 DEC 94 AND IT IS BELIEVED THAT THE POPULATION HAS MOVED SOUTHWARDS TO OTHER CAMPS.

C. TUNBATT HAVE REPORTED THAT A NUMBER OF CHILDREN IN KANYAMIHETO (GR 5140) HAVE LEFT THEIR SCHOOLS BECAUSE OF RUMOURS THAT THE FRGF WILL LAUNCH THEIR OFFENSIVE SOON.

2. POLITICAL ACTIVITIES. THE SRSG MET WITH THE MINISTER OF REHABILITATION TO DISCUSS "OPERATION RETOUR" AND THE INTEGRATED OPERATIONS CENTRE. HE THEN CONSULTED WITH THE MINISTER FOR PUBLIC WORKS REGARDING COORDINATION AMONG THE VARIOUS DONORS. HE MET WITH DR. DENG, THE UN REPRESENTATIVE OF THE SECRETARY GENERAL ON INTERNALLY DISPLACED PERSONS TO DISCUSS "OPERATION RETOUR". HE THEN HELD CONSULTATIONS WITH THE PERMANENT MEMBERS OF THE SECURITY COUNCIL AND THE UNDP RESIDENT REPRESENTATIVE TO DISCUSS THE ADMINISTRATION OF THE TRUST FUND.

3. FACTIONAL ACTIVITIES.

A. RPA. RPA CONTINUED ROUTINE DAY AND NIGHT FOOT AND MOBILE PATROLS AND MOUNTED SNAP ROAD BLOCKS IN MAJOR TOWNS AND VILLAGES THROUGHOUT THE COUNTRY.

(1) SECTOR 3A HQ REPORTED THAT LOCALS IN THE NDORA (GR 8112) AREA HAVE COMPLAINED THAT THE RPA HAVE ARRESTED MANY PEOPLE THERE OVER THE COURSE OF THE LAST FEW WEEKS.

(2) GHANBATT HAVE REPORTED THAT A MAN WAS MURDERED IN NPATSWE (GR 479037) AT APPROX 062000B DEC 94. 2 BAGS CONTAINING CLOTHING AND MONEY WERE TAKEN FROM THE SCENE. ON THE MORNING OF 07 DEC 94 A PAIR OF CHILDREN WERE TAKEN TO RUKO RPA CAMP IN AN ATTEMPT TO IDENTIFY THOSE RESPONSIBLE. 1 RPA SOLDIER WAS IDENTIFIED BUT THE RPA DENIED THE ALLEGATION.

(3) MILOBS IN SECTOR 4B HAVE REPORTED THAT THE RPA HAVE ARRESTED 37 PEOPLE IN RWAMATAMU COMMUNE SINCE MID OCT 94. NO FURTHER INFORMATION ON REASON FOR ARREST OR THE WHEREABOUTS OF THE PRISONERS.

(4) MILOBS IN SECT 4C HAVE REPORTED THAT ALTHOUGH THE SECTOR IS REPORTED TO BE CALM ALL AREAS REPORT THAT THE RPA ARE INCESSANTLY HARASSING THEM, ARRESTING PEOPLE, STEALING THEIR PROPERTY AND OCCASIONALLY KILLING PEOPLE.

(1) NORMAL ROUTINE WORK WAS CONDUCTED DURING THE PERIOD.

(2) THE ACTING FC MET WITH DR. DENG, UN REPRESENTATIVE OF SEC GEN ON INTERNALLY DPs AND THE SRSG FOR DISCUSSIONS.

(3) HE THEN MET WITH PERMANENT MEMBERS OF SECURITY COUNCIL, MR. RHAZOU OF UNDP AND SRSG.

(4) HE AGAIN MET WITH DEFENCE MINISTER FOR ETHIOPIA, H.E MR. SYE ABRAHA.

(4) 30 ADULTS AND 12 CHILDREN CAME INTO RWANDA THROUGH RUSUMO BORDER POST TODAY.

(5) GHANBATT OPS OFFR VISITED 2B LOC TO ASSESS THE CAMP PRIOR TO TAKING OVER. ARRANGEMENTS ON THE ISSUE WAS INCONCLUSIVE BECAUSE HIS TROOPS WERE STILL COMMITTED ELSEWHERE.

(6) AT KINYAMI, A HAND GRENADE BEHIND THE CLINIC EXPLODED AND KILLED A 7-YEAR OLD CHILD ON 06 DEC 94 BEFORE OWN ENGRS ARRIVED IN THE AREA.

(2) ANOTHER PTL WAS SENT TO MAMBA GR 6107 AND BANGA

GR 5609 AND REPORTED THE GEN SIT WAS CALM AND MANY PEOPLE WERE SEEN BUSY CULTIVATING IN THEIR FIELDS. PTL WAS ALSO SENT TO KANYANZA GR 6391 AND REPORTED THAT MANY LOCALS ARE RETURNING TO THEIR HOMES.

(2) MILOBS PTL NYENJI GR 79071, NYAMASHEKE GR 9842 AND MWITO GR 8634. LOCALS COMPLAINED OF CONSTANT HARASSMENT, ARRESTS, LOOTING AND SOMETIMES KILLINGS BY RPA IN THE AREAS PTL.

(10) IN SECTOR 5-GISENYI.

(A) THE SECT WAS REPORTED CALM DURING THE PERIOD. ADRA HOSP AT MUTURA GR 3123 REPORTED THAT 2 BOYS WERE TREATED FOR MULTIPLE INJURIES SUSTAINED DURING AN EXPLOSION IN AREA. HOSP AUTH ALSO REPORTED FREQUENT ARRESTS OF SOME LOCALS BY RPA. SOME OF THESE LOCALS WERE RELEASED AFTER SOMETIME WHILE OTHERS CONTINUE TO BE HELD. ON 06 DEC 94 2 PERS WERE TREATED FOR INJURIES RECEIVED AFTER ARREST BY RPA.

(B) MILOBS PTL GISENYI AND BORDER POSTS. PTLs WERE CARRIED OUT WITH UNHCR PERS WHO WANTED TO MONITOR HUMANITARIAN SIT AND ROAD CONDITIONS IN THESE AREAS. RPA QUITE CO-OPERATIVE WITH MILOB PTLs. RPA LOCAL COMD FOR MUTURA, MOTOVU AND RWERERE REPORTED INFLUX OF RETURNEES THROUGH WESTERN FOREST AREAS BUT GAVE NO FIGURES.

(C) SECT MILOBS MET A/DIR UNHCR GOMA AND SNR PROTECTION OFFR AND DISCUSSED CURRENT SIT IN GOMA. IT WAS NOTED THAT MOV OF APPROX 120,000 RWANDESE REFUGEES FROM NORTHERN "UNOFFICIAL CAMPS" BY ZAIRE ARMY WAS NOT SANCTIONED BY LOCAL ZAIRE AUTHORITIES. ZAIRE MILITARY NOT PROVIDING SY FOR REFUGEES AS THEY ARE RELOCATED IN NEW AREAS. AS CAMPS POPULATION INCREASED PROBLEMS OF OVER CROWDING AND NEW CAMP LEADERSHIP STRUCTURES WERE EXPECTED TO AGGRAVATE ALREADY TENSE SIT IN THE CAMP. FURTHER DETAILS LATER.
