NOTE ON SECURITY COUNCIL INFORMAL CONSULTATIONS 30 June 1994

RWANDA

The Security Council continued its consultations today on a draft resolution which, if adopted, would establish a Commission of Experts to investigate the atrocities in Rwanda. At yesterday's consultations, China had requested deletion of any reference to the High commission for Human Rights and the Special Rapporteur on Rwanda. The President had requested China and Spain to consult on this issue before today's meting.

Today China noted that, regarding the draft resolution (sponsored by Spain), its concerns had not been taken care of. China was waiting for instructions from its capital. Government. Spain stated that the first version of the text was distributed three weeks ago. Delegations had had a chance to review it. The time had come to reach a decision, and a vote on the resolution should be taken this afternoon or tomorrow. China responded that although it was included on the consultation list, actual consultations had not yet taken place. He called for consultations to take place today.

The President noted that there appeared to be a need for further consultation. This should be finalised as soon as possible. Spain expressed readiness to continue with consultations, but wished to note that adopted resolutions of the Security Council, were not always presidential texts; they could be delegation-sponsored texts, as in this instance. Spain called for a vote on the draft resolution this afternoon or tomorrow morning. China agreed with Spain on the need for a vote today or tomorrow.

It was agreed that the Council will take up Rwanda tomorrow.

The Security Council,

Reaffirming all its previous resolutions on the situation in Rwands,

Reaffirming, in particular, resolutions 918 (1994) and 925 (1994), which expanded the United Sations Assistance-Mission for Reside (UNAMIR), and attracting in this connection the meed for early deployment of the expanded UNAMIR to enable it to carry out its mandate,

Excelling the estatement by the President of the Socurity Council of 30 april 1994 (8/PRET/1994/21) in which the Security Council, inter_nin, condemned all breaches of international humanitarian law in Rusada, particularly those perpetrated against the civilian population, and recalled that persons who instigate or participate in such acts are individually responsible,

Recalling also the requests it addressed to the Secretary-Concral in the exament by the Freeidest of the focurity Council of 30 April 1994 and in resolution 918 (1994), concerning the investigation of serious violations of integrational humanitarian law committed in Ewanda during the conflict,

<u>Maying considered</u> the report of the Socretary-Constal of 31 May 1994 (8/1994/640), in which he noted that massacros and killings have continued in a systematic manner throughout Evanda and also noted that only a proper investigation can establish the facts in order to enable the determination of responsibility,

Melaming the visit to Reside and to the region by the United Mations Might Commissioner for Susan Rights and notice the appointment, pursuant to resolution 3-3/1 of 15 May 1994 adopted by the United Mations Commission on Numan Rights, of a Special Repportour for Ewanda,

Exprension once again its grave concern at the continuing reports issicating that systematic, widespread and flagrant violations of international humanitarian law, including acts of genocide, have been committed in Rwanda,

Recalling that all persons who commit or authorize the commission of serious violations of international humanitarian law are individually responsible for those violations and should be brought to justice,

- 1. Requests the Secretary-General to establish, as a matter of urgency, an impartial Commission of Experts to examine and analyse information subsitted pursuant to the present resolution, together with such further information as the Commission of Experts may obtain through its own investigations or the efforts of other persons or bodies, including the findings of the Special Rapporteur for Rwands, with a view to providing the Secretary-General with its conclusions on grave-violations of international humanitarian law committed in the territory of Rwands, including the evidence of possible acts of genocide;
- 2. Calls upon States and, as appropriate, international humanitarian organizations to collete substantiated information in their possession or submitted to them relating to grave violations of international humanitarian law, including breaches of the Convention on the Provention and Punishment of the Crime of Genocide; committed in Evanda during the conflict, and requests States, relevant United Nations bodies, and relevant organizations to make this information available within thirty days of the adoption of the present resolution and as appropriate thereafter, and to provide appropriate assistance to the Commission of Experts referred to in paragraph 1;
- 3. Requests the Secretary-General to report to the Council on the establishment of the Commission of Experts, and further requests the Secretary-General, within four months from the establishment of the Commission of Experts, to report to the Council, on the conclusions of the Commission and to take account of these conclusions in any recommendations for further appropriate steps;
- 4. Also requests the Secretary-General and as appropriate the High Commissioner for Human Rights to make the information summitted to the Special Rapportsur for Avanda available to the Commission of Experts and to ensure that adequate coordination and cooperation is maintained between the work of the Commission of Experts and that of the Special Rapportsur;
- 3. <u>Urosa all</u> concerned fully to cooperate with the Commission of Experts in the accomplishment of its mandato;
