    - (a) REFERENCE OUR SITREP COVERING PERIOD 021600B DEC TO 031600B DEC ABOUT THE 5 DEAD CHILDREN FOUND IN THE FOREST, INVESTIGATION REVEALED THAT THE GIRLS WERE RAPED AND 5 OF THEM WERE CHOKED TO DEATH. MULTIPLE INJURIES WERE FOUND ON THE THEIR PERSONS. THE 6TH VICTIM WAS RUSHED TO THE RUHENGERI HOSPITAL IN A COMA AND KEPT UNDER UN CUARD. SHE DIED LAST NIGHT OF HER WOUNDS.
