- 1. GENERITATION: 139ERVED TO BE VERY TENSE. THE SECURITY SITUATION IN RWANDA AND IN PARTICULAR KIGALI CITY IS DETORIATING. THERE MERE FEW ROAD BLOCKS, LOT OF SHOOTING INCIDENTS AND GRENADE EXPLOSIONS AT KIGALI CITY. TWO CONFIRMED DEATH CASE REPORTED. SEVERAL INJURED PERSONNEL HAVE REPORTED TO THE UNAMIR FIELD ROSPITAL. PEW BANDITRY INCIDENTS TOOK PLACES IN VARIOUS PLACES IN THE TOWN. 039ERVING AND AFTER QUESTIONING MEDICAL PERSONNEL AT RIGALI HOSPITAL IT SEEMS NOT THAT THERE IS AN ETHNIC PURIFICATION STARTED, IT IS MORE AN INDISCRIMINATE KILLING WITH SOME POLITICAL BACKGROUND DURING LAST FEW DAYS, LOCAL PROPLE ARE IN PANIC ALL OVER KIGALI CITY
- 2. POLITICAL ACTIVITIES. TRANSITIONAL INSTITUTIONS STILL NOT INSTALLED. NEGOTIATIONS ONGOING. A MEETING OF THE POLITICAL PARTIES WAS HEADED BY THE PRESIDENT OF THE REFUBLIC. THE AIM OF THE MEETING WAS TO FIND A POLITICAL COMPROMISE TO FACILITATE INSTALLATION OF THE BSIG. THE TALKS WILL BE CONTINUED NEXT SUNDAY. AT 251030 HOURS SRSG HAD A MEETING WITH THE REPRESENTATIVES OF THE RWANDESE PATRIOTIC FRONT (RPF). AT UNAMINE HQ. SRSG HAD A MEETING WITH THE AMBABBADOR OF GREAT BRITAIN IN UCANDA, H. Z. MR. EDWARD CLAY AT 1200 HOURS IN THE UNAMIR HQ.

3. FACTIONAL ACTIVITIES.

- (1) FORCE COMMANDER EFFORTS IN HAVING A MEETING WITH RPP COMMANDER MAJOR GENERAL KAGAME ON THE ISSUE OF DMZ VIOLATION (RPP POSITIONS IN DMZ) HAVE BEEN DENIED SEVERAL TIMES. HOWEVER, FORCE COMMANDER WILL TRY TO MEET CEMERAL KAGAME AS SOON AS POSSIBLE. A FORMAL PROTEST IN THIS REGARD WILL BE LODGED ASP.
 - (2) THE RPP BATTALION COMMANDER LOCATED AT CND COMPLEX IS NOT ALLOWING ANY UNNO TO GET INSIDE CND COMPLEX. HE IS ALSO TELLING UNNOS WORKING INSIDE CND TO GET OUT FROM THE COMPLEX.
 - (3) ON 251005 FBB 94 VICE CHAIRMAN OF RPF LEFT CND ON THE WAY TO AMAHORO WITHOUT BSCORT.

C. OTHERS.

(1) SOME FAMILIES RESIDING IN KICUKIRO AREA REPORTED TO THE HEADCUARTERS THAT THEIR LIVE IS UNDER THREAT. THEY REQUESTED SECURITY AS SUCH KIGALI SECTOR HQ TRIED TO GET ASSISTANCE FROM GENDARMERIE BUT GENDARMERIE DENIED TO TAKE ANY COMPLAIN/REPORT IN THIS REGARD.

D. MILOB. CARRIED OUT ESCORT FOR A UNAMIR CONVOY CONSISTING OF HIME CONTAINERS FROM RUSUMO (TANZAMIA BORDER) TO KIGALI. ESCORTED FOR THE BRITISH AMBASSADOR FROM KIGALI TO GATUNA AND SYUMBA. CARRIED OUT ESCORT FOR RPF (19 MILITARY, 55 WOMEN, 4 BUSES) FROM MULINDI TO KIGALI.

(1) ROW SECTOR

- A) TWO HAND GRENADE ATTACKS CCCURRED IN THE NIGHT OF 24/25 FEB IN GISENYI. THE PIRST ATTACK WAS ON THE HOUSE OF MR. SEMUCYO, A TEACHER FROM NYUNDO. HE IS TUTSI AND PL PARTY MEMBER. THE SECOND ATTACK WAS CARRIED OUT AGAINST MR. ARISTARQUE, ACCOUNTANT AND HUTU, HE IS HARRIED TO A TUTSI AND COMES FROM RUHENGERI. HIS 16 YEARS OLD LAUGHTER WAS SERIOUSLY INJURED.
- (B) FOUR CONTAINERS FOR RUTBAT CROSSED THE BCRDER FROM TANEANIA TO RNANDA. TEN CIVILIAN TRUCKS WITH BUILDING MATERIAL ALSO CROSSED THE BORDER PROM TANZANIA TO RWANDA.
- (C) RGP SECTOR COMMANDER REQUESTED FOR A PERMANENT CIVPOL STATION IN GISENYI TO FACILITATE INVESTIGATIONS AND LIAISON WITH GENDARMERIE.

- (A) RPF OFFICERS AND SOLDIERS ARE DISAPPOINTED BECAUSE OF THE FAILURE OF THE INSTALLATION OF THE ESTC.

THE MATTER.

- KIGALI SECTOR. ONE RIOT TOOK PLACE AT AREA KICHUKIRU AND KABIZA BETWEEN TWO RIVALRY GROUPS AT AROUND 1800 HOURS ON 25 FEB 94 AS A RESULT OF WHICH A GROUP OF ABOUT 65 TO 70. PROPILE INCLUDING WOMEN AND CHILDREN CAME TO AMAHORO STADIUM FOR SHELTER. THEY WERE EVACUATED TO CENTER CHRISTUS CHURCH GR 132842. THESE PEOPLE WERE KEPT UNDER THE SUPERVISION OF GENDARMERIE. THE VICTIMS REPORTED THAT THEY HAVE BEEN ATTACKED BY TOR PARTY MEMBERS. A PLATOCH STRENGTH NAS EMPLOYED: CN 25 FEB. 94: TO PROVIDE PROTECTION ON THE ROAD FROM GADDAFI GROSS TO SQ: 0690, ON 251500 FEB 94 SECTOR COMMANDER ATTENDED A MEETING WITH THE RPF AND RGF PERSONNEL AT KIGALI SECTOR HQ ABOUT. KWSA. CM 25 FEB TWO RPF MEMBERS WERE APPREHENDED BY THE GENDARMERIE PERSONNEL AT RUGENCE AREA. SECTOR XIGALI CONDUCTED VEHICLE AND FOOT PATROL IN KIGALI CITY IN ORDER TO ENSURE KIGALI WEAPON SECURE ARBA (XMSA). PROVIDED 8 UNMO ESCORTS FIVE FOR RPF, ONE FOR ROF AND TWO FOR CENDARMERIE PERSONNEL. PROVIDED FOUR ARMED EBCORTS: CHE POR PRIME MINISTER; THO FOR RPF AND CHE FOR SRSG. SECURED THE LOCATION OF THE RPF BATTALION IN KIGALI CITY, PRIME MINISTER'S OFFICE, FORCE HQ, SECTOR HQ AND KIGALI AIRFORT. DURING THE NIGHT ASSURED THE PROTECTION OF THE PRIME MINISTER DESIGNATE, THE PRESIDENT OF THE CONSTITUTIONAL COURT, FIVE OPPOSITION MINISTERS AND SREG.
- 5. UNCIVED. THE SITUATION IS STILL TENSE BECAUSE OF THE DELAY OF INSTALLING THE BETG. CIVPOL INVESTIGATED IN THE CASE OF ALLEGED MURDERING ON MR. KALINGANIRE JOSEPH, A MEMBER OF THE MDR. THE INVESTIGATION TEAM VISITED CRCD AND GOT INFORMATION ABOUT THE CASE, MUBURAKALI TOLD THEM THAT INFORMATION ABOUT THE KILLING WAS NOT CORRECT! THE ABOVE MENTIONED PERSON IS STILL ALIVE.
