1. (C) THE RPF HAS COME FORWARD WITH A DECLARATION OF A UNILATERAL CEASEFIRE TO BEGIN AT 2400 HOURS GMT ON MONDAY, APRIL 25. THE CEASEFIRE PROPOSAL IS CONTAINED IN A WIDE-RANGING RPF DOCUMENT THAT:

-- CALLS ON THE RWANDAN GOVERNMENT TO BRING VIOLENCE UNDER CONTROL WITHIN 96 HOURS AFTER THE CEASEFIRE STARTS;

-- ASKS THE RESIDUAL UNAMIR FORCE TO VERIFY THE CESSATION OF HOSTILITIES AND VIOLENCE; AND

-- URGES THE INTERNATIONAL COMMUNITY TO ESTABLISH "TRIBUNALS" TO INVESTIGATE THE CAUSES OF THE VIOLENCE IN RWANDA.
